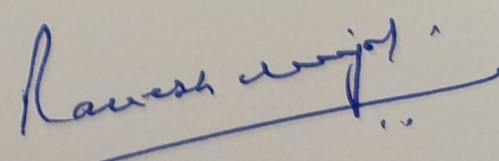
DECLARATION OF RESULT
OF BAR COUNCIL OF DELHI ELECTIONS – 2026

As you are aware, the Hon'ble Supreme Court, in SLP (C) No. 21926/2026, titled *Rudra Vikram Singh Vs. Bar Council of Delhi & Anr.*, along with the connected matters, passed an order dated 14.08.2026, whereby the petitions were disposed of.

The Hon'ble Supreme Court, inter alia, issued the following directions:

- “ 5. We direct the Bar Council of Delhi to preserve the entire record, including the original CCTV footage and the videography recordings and produce the same before the Tribunal(s).
6. Meanwhile, the results will be declared, but the same shall be subject to the outcome of the petitions before the Tribunal (s)
8. The Delhi Police is also directed to preserve the original CCTV footage and provide a copy thereof to the Delhi State Bar Council.”

In terms of the directions of Hon'ble Supreme Court dated 14.08.2026, the Election Result of Bar Council of Delhi Elections – 2026 is enclosed herewith, which shall be subject to the outcome of the petitions before the Tribunal(s).

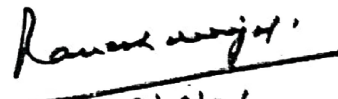
