CORRIGENDUM NOTIFICATION
REGARDING FILLING-UP VERIFICATION FORM

This Corrigendum Notification is being issued in pursuance of the communications dated 14.01.2024 and 03.02.2024 received from Bar Council of India with respect to the filling-up the Verification Forms/Declaration Forms. This Corrigendum Notification supersedes the earlier notifications dated 21.11.2023, 28.11.2023 and 23.12.2023 issued by the Bar Council of Delhi. All the Learned Advocate Colleagues are requested to fill up the Verification Forms/Declaration Forms as per criteria mentioned herein in this Corrigendum Notification. Those who have already filled-up their verification forms in pursuance to our earlier notifications dt. 21.11.2023, 28.11.2023 and 23.12.2023, need not fill-up the Verification Form/Declaration Form again. However, a list of those advocates whose filled-up verification forms were not found to be in order or not in accordance with the present corrigendum notification, has been uploaded in the website of BCD and they need to fill up the present Verification Form afresh according to the criteria mentioned in the present Corrigendum Notification. The inconvenience is highly regretted.

The detailed criteria for filling up the Verification Form is as follows :

A. Advocates who were enrolled on and before 31.12.1989 :

The advocates falling in this category are required to fill-up only the Declaration Form. All such advocates are not required to upload any documents relating to their education qualifications, and they are only required to upload either five Vakalatnamas or five self-attested Court Orders or file

copies of the orders downloaded from internet, showing that they are in active practice. In case such advocates are working as Notary Public/doing documentation work/Oath Commissioners/working in law firms/doing taxation work, are required to upload appropriate certificates/experience certificates, showing that they are in active practice in that particular field.

B. (i) Advocates who were enrolled on and after 01.01.1990 till 31.12.2018, and not filled-up the Verification Form during the verification process undertaken by the Bar Council of Delhi in 2016.

The Advocates falling in this category, are required to fill-up Form-A. They are required to upload all their education qualification certificates i.e. 10th 12th, Graduation Degree & Mark-sheets and LL.B. Degree and have to upload either five Vakalatnamas or five self-attested Court Orders or file copies of the orders downloaded from internet, showing that they are in active practice. In case such advocates are working as Notary Public/doing documentation work/Oath Commissioners/working in law firms/doing taxation work, are required to upload appropriate certificates/experience certificates, showing that they are in active practice in that particular field.

(ii) Advocates who were enrolled on and after 01.01.1990 till 31.12.2018 and filled-up the Verification Form during the verification process undertaken by the Bar Council of Delhi in 2016.

The Advocates falling in this category are required to fill-up Only Form-A1. They are not required to upload their education qualification certificates. They are only required upload either five Vakalatnamas or five self-attested Court Orders or file copies of the orders downloaded from internet, showing that they

are in active practice. In case such advocates are working as Notary Public/doing documentation work/Oath Commissioners/ working in law firms/doing taxation work, are required to upload appropriate certificates/experience certificates, showing that they are in active practice in that particular field.

C. (i) Advocates who were enrolled on and after 01.01.2019 till date, whom AIBE (All India Bar Examination) is applicable.

Advocates falling in this category are required to fill-up Form-A2. They are required to upload their education qualification certificates i.e. 10th 12th, Graduation Degree & Mark-sheets and LL.B Degree, COP/Permanent Enrolment Certificate. However, advocates who are enrolled after 01.01.2019 and have passed AIBE and have not completed five years are not required to upload five Vakalatnamas/five self-attested Court Orders/copies of the orders downloaded from internet, etc.

(ii) Advocates who were enrolled on and after 01.01.2019 till date, whom AIBE (All India Bar Examination) is not applicable as they have passed their LLB before July, 2010.

The Advocates falling in this category are required to fill-up Form-A. They are required to upload all their education qualification certificates i.e. 10th 12th, Graduation Degree & Mark-sheets and LL.B. Degree and have to upload either five Vakalatnamas or five self-attested Court Orders or file copies of the orders downloaded from internet, showing that they are in active practice. In case such advocates are working as Notary Public/doing documentation work/Oath Commissioners/working in law firms/doing taxation work, are required to

D. Senior Advocates and Advocates On-Record :

Designated Senior Advocates and Advocates on Record of Hon'ble Supreme Court of India are required to fill up **Form-E** only. They have to fill-up self-details and upload only signature and photograph.

The notices dated 21.11.2023, 28.11.2023 and 23.12.2023 issued earlier in this regard, may please be treated as withdrawn and the same have been removed from the website.

The last date of submission of filling-up Verification Form is **30.04.2024** and shall not be extended further.
