NOTICE

1. The learned Advocates enrolled with Bar Council of Delhi are informed that as per Rule 5 of the Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015, read with Gazette Notification for amendment of Rule 32 dated 23.06.2023, an advocate is not entitled to practice law unless he holds a valid Certificate of Practice as per Rule 8.1. & 8.2, which reads as under:

8.1 An advocate graduating in law in academic year 2009-2010 (1st July, 2009 to 30th June, 2010) and thereafter, enrolled on the "Roll of Advocates" on or after June 12, 2010, is required to apply for issuance of "Certificate of Practice" under All India Bar Examination Rules, 2010 and for verification of such "Certificate of Practice" from the State Bar Council in which he/she is enrolled as an advocate under rule 9.

8.2. An advocate having obtained graduate degree in law before the academic year 2010 enrolled on the "Roll of Advocates", is required to apply for verification of "Certificate of Practice and Place of Practice" from the State Bar Council in which he/she is enrolled as an advocate under this Rule within a period of 6 months of the enforcement of these rules/dates of enrolment.

For this purpose, Bar Council of Delhi is uploading a digital verification form i.e. "FORM-A" as per Certificate and Place of Practice (Verification) Rules, 2015 of Bar Council of India. All the advocates are requested to kindly fill-up this FORM-A online uploading all the documents which are necessary and mentioned in this form.

It is further clarified that Advocates-on-Record of the Hon'ble Supreme Court and also designated Senior Advocates are exempted under Rule 5(a) of the Notification dated 12.01.2015. They would be required to fill a separate form, i.e.- "FORM-E" as specified in the Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015, and they are not required to fill up FORM-A.

This exercise is being carried in view of the forthcoming general election for the next term of Bar Council of Delhi, all the Advocate colleagues are mandatorily required to submit the verification forms, on the basis of which electoral roll has to be prepared. The online form link shall be live from 16/11/2023 and all advocates shall be required to fill the same online, please.
