Through this letter, I would like to bring to your kind notice that the office of Bar Council of Delhi has been sending copies of LL.B. Degree Certificates of Law Graduates to the respective Universities for verification, as the Bar Council of Delhi has now adopted the procedure of enrolling only those law graduates as Advocates on its roll, whose verification report has been received from the respective Universities, to the effect that the same is genuine.

Accordingly, copies of LL.B. Degrees of various candidates, (approximately 1500 so far) who obtained LL.B. Degrees from CCS University, have been sent to your esteemed University, for verification. However, I am sorry to inform your goodself that the office of CCS University is not sending the verification reports, whereas we are receiving verification reports regularly from almost all the Universities. As your goodself is aware, a considerable number of law graduates applying for enrolment are from CCS University and because of non-receipt of verification reports from CCS University, these law graduates are stuck in the limbo and this long delay in receipt of verification report would severely affect the future prospects of these law graduates, and regularly we face enquiry from these students regarding their enrolment.


